## **Meeting Notes**

## 1. FY 2018 Budget/Appropriations

- Recapped Center on Budget and Policy Priorities (CBPP) call with LCAO Co-Chairs regarding the Republican FY 2018 budget resolution and reconciliation timeline to move tax reform by the December holidays. Also previewed predictions about using FY 2019 budget/reconciliation process to advance spending cuts to mandatory/non-defense discretionary programs, as well as the projections for an FY 2018 budget deal/final spending bill.
- Community Services (CS) co-chairs will draft an LCAO sign-on letter regarding the support for a bipartisan budget deal for FY 2018-2019, similar to efforts in the past
- Expressed support for broader coalition advocacy effort on tax/spending cut strategy
- 2. Advocacy Efforts/Scheduling Meetings to react to House/Senate Appropriations Bills
  - Discussed meeting targets, including House and Senate Approps Leadership, Defense Appropriators (NEW), LHHS Subcommittee Members; CS Committee Members volunteering for setting-up meetings

    - Current OAA reauth expires September 2019
  - Discussed next steps for coalition
    - First steps: scheduling call with Hill staff who have been asking about OAA reauth priorities (Senate Aging, HELP)—what are they thinking and what do they want to know from aging orgs/coalitions right now?
    - Continue to keep this on the agenda and develop a timeline for coalition work in the coming months
