#### 1. Omnibus FY18

- a. See Justice in Aging email with subject: Older Adult Program Funding in 2018
- b. SSA received an increase in funding.
  - i. Much needed after receiving several decreases over the past decade.
  - ii. Discrepancy in what has been seen in LAE funding is actual administrative versus IT costs, program integrity, and discretionary expenses.
  - iii. Cause for self-congratulation
    - 1. LCAO made a point in our appropriation letters asking for these increases and many groups did outreach and pushed Dear Colleague letters on this matter.
  - iv. Report language referenced office closings.
    - 1. This is important because appropriators go on record that this is of concern.
    - 2. They requested to learn more about what is causing this.
  - v. Report language also asked for SSA to report what they actually require to carry about operations within a certain time period (90 days?).

## c. Housing

- i. \$678 million for section 202 program, \$105 million for new construction and PBRA.
  - 1. 105 million for new construction will be first time a substantial amount as been appropriated towards this since FY11.
- ii. Increased funding for Housing Choice vouchers, public housing and homeless assistance among other programs.

## d. SNAP

i. There was a cut to SNAP and an addition of work requirements that the committee would like to know more about. Hoping to learn more at next full LCAO meeting.

## 2. FY19 Appropriations

- a. Dear Colleague letter on SSA funding (Crowley/Larson)
  - They sent a letter to the Appropriations Committee along with 100 other members about their desire for SSA funding to receive proper funding in FY19
  - ii. Letter for FY18 was obviously successful, hoping to promote this the same way.
- b. Working with increased discretionary spending caps.
- c. Not anticipating a budget resolution in Senate, House will most likely do one.
- d. Anticipate that they will continue doing CR's to the lame duck session and continue from there.

- e. There will most likely be a Balanced Budget amendment.
  - i. Republicans would like to introduce this despite passing a huge tax break.
  - ii. Every time they do this, there's a question about whether there should be a carve out for defense, and how to treat Social Security revenues.

  - iv. Despite all of this, Republicans will want to proceed with an infrastructure package and a rumored second Tax Cut.

## 3. Social Security Legislation

- a. BASIC Act (Rep. DeFazio) HR 5302
  - i. Benefit Adjustment of Social Security Income Compensation Act
    - 1. Protects benefits for families of deceased veterans and social security beneficiaries by prorating based on the date of the beneficiary's death.
  - ii. Identical, companion in senate, introduced by Sen. Murphy (S. 1739)
- b. Strengthen Protections for Social Security Beneficiaries Act of 2018 (HR 4547)
  - i. Passed senate with Unanimous consent.
  - ii. Creates better process for Rep Payees
- c. Strengthen Social Security Act, Rep. Sanchez
  - i. Looking to reintroduce
  - ii. HR 5952 in 114<sup>th</sup> Congress.
- d. Sen. Sanders is looking to introduce a bill that would restructure SSA funding, particularly the way LAE allocation is restricted.

#### 4. Future meetings

- a. Income Security co-Chairs will try to get someone from the Joint Select Committee on Appropriations.
  - i. It appears they were all on vacation after passing the Omnibus and were unable to join the meeting.
- b. The Senate Aging committee will be speaking to us in April.
  - i. They are working on something of interest to the Income Security committee.
- 5. Gideon Bragin, Sen. Brown's office, Joint Select Committee on Pensions
  - a. The committee is currently organizing and coming up with a schedule, there's a lot to set up: staff, office space, and scheduling hearings.
  - b. The committee will hold 5 hearings.
    - i. The first hearing will be in the Spring, followed by others in the Summer
  - c. Interested groups can participate by including our ideas during the calls for public comment, and testifying at hearings.

- d. The committee and LCAO will be able to support member efforts during the hearing.
- e. Now would be an important time to be involved if you're interested in pension issues
- f. The committee will report out in November 2018.
