# LCAO Health Committee Meeting Minutes April 23, 2018

## 1. Opioid Legislation is moving

- House Energy and Commerce Summary; 60+ bills—some addressing Medicare and Medicaid; marking up this week (Wednesday 4/25)
- Senate **HELP Summary** also marking up this week
- Finance and W&M moving less quickly
- NCOA looking at materials—have a few draft Medicare recommendations:
- Prevention—screening and referrals—broader training and adoption of Screening, Brief
   Intervention, and Referral to Treatment (SBIRT) tool; possible opportunities in annual Medicare
   Wellness Visit
- Medication Assisted Treatment (MAT)—developed by SAMHSA, methadone only reimbursable for inpatient but not outpatient
- o Non-pharmacologic evidence based treatment access (self-management, medication management)
- AMDA Talking Points
- Families USA has a new fact sheet
- Community Catalyst's SUD team also working on this
- We will look for consensus to make recommendations from LCAO, possible letter
- 2. Update on HCBS Money Follows the Person and Balancing Incentive Payments 2.0
  - MFP—focus on House Hill visits and build co-sponsors; still long shot; lame duck seems most likely; maybe only 1 or 2 year extension; additional cosponsors have recently joined; Congressional staff seems to lack knowledge about the program; need help with Hill visits (sign up via the <u>Doodle forms</u>)
  - BIP 2.0—circulating ideas based on Anne Montgomery's paper; hoping to have specs of a bill in May (Reps. Dingell & Guthrie)

### 3. Update on Medicaid waivers

- KY case staying in DC; oral argument on the Plaintiffs' motion for summary judgment scheduled for June. Justice in Aging, AARP, National Academy of Elder Law Attorneys, Disability Rights Education And Defense Fund submitted an <u>amicus brief</u>.
- Michigan proposal: <u>CBPP issue brief</u>; MI Senate passed the work requirement bill last week—timing in House unclear;
- TN Senate passed a bill—heading to governor; Oklahoma bill moving quickly and expected to pass
- New Justice in Aging fact sheet on work requirements
- Non-LCAO sign-on letter urging Sec. Azar to address concerns raised in <u>a recent GAO report</u> and halt approvals of 1115 waivers that have the effect of limiting eligibility, reducing enrollment, or curtailing program benefits until HHS demonstrates it has the capacity to conduct comprehensive public evaluations of its existing waivers. <u>Click here</u> to see the letter and sign-on. <u>Deadline is COB May 4</u>.
- We are also watching the Farm Bill—would expand SNAP work requirement up to age 60
- <u>State Medicaid Director letter on how the look-back period for asset transfers applies to HCBS 1915(c)</u> waiver applicants (will discuss more at a future meeting)
- 4. Electronic Visit Verification; Some groups are following—will discuss more at a future meeting
  - Part of 21<sup>st</sup> Century CURES Act—January 2019 compliance; Response to OIG reports w/ concerns about fraudulent billing for "personal care services or home health care services requiring an inhome visit by a provider"

  - Opioids--Hoping for a bipartisan set of bills/policies to be considered as part of a larger opioid package
    for later on in the fall; does not expect a stand-alone bill—so HELP, judiciary, E&C, W&M package that
    rides on another vehicle—unlikely before August recess; decisions on what is included will be based on
    whether the bills are big costers; some offices interested in discharging bills without offset; committee
    ready to have scored, thought out bills before August recess
  - Part C & D changes (Matt Kazan); Part B changes (Beth Vrabel); Medicaid (Anne Dwyer)
  - Wyden—continued focus on Marketplace; oversight of Admin; we should stop calling it the ACA because Marketplace doesn't look like the ACA—it's been undermined; letter from 47 senators on STLDI; monitoring Medicaid waivers & work requirements
  - Drug pricing—POTUS speech postponed; monitoring HHS plans to use CMMI aggressively
  - Medicare Improvement Bill—Wyden would be happy to reintroduce but want to make sure they're
    moving policies that others want too
  - Very proud of getting CHRONIC Care bill passed
  - MFP—OR & UT don't have MFP, need a bigger push from bill's sponsors, supporters
