- 1. Retirement Account bill-- Jeremy Woodrum, Office of Rep. Joe Crowley (NY-14)
 - a. Introduced this last Congress, modified for this Congress.
 - i. SAVE UP Act: Universal Pension Program
 - ii. 114th Congress: HR 5731
 - b. Targeted towards those that receive no retirement benefits through their employer
 - c. A mandate to all employers to contribute \$0.50 per hour to an employee's retirement account.
 - i. Could go private, similar to government retirement accounts.
 - ii. Low-end estimations, without employee contributions, could generate mid 100,000s.
 - iii. Refundable savers credit, refunding half back to an employee that contributes.
 - iv. Would provide assistance to small employers to carry this out.
 - 1. Up to 10 employees
 - v. Significant tax penalty for not participating in the mandate.

- 2. Social Security proposal-- Keith Miller, Senate Comm. on Aging (Sen. Bob Casey, PA)
 - a. Improving Social Security benefits for especially vulnerable groups.
 - b. Working with SSA on language and logistics in the bill.
 - i. Increase benefits for survivor benefits for a spouse, widow or widower, or surviving divorced spouse with disabilities.
 - 1. These beneficiaries can claim at age 50 with a significantly reduced amount. This bill would increase that amount.
 - ii. Increase benefits for widow with child amount by raising age limit from 16 to 18.
 - iii. Allowing the minimum survivor benefit to grow past the current standard (based on when the person claimed, delayed or not).
 - 1. Widowed beneficiaries who wait until their full retirement age to claim benefits (based on deceased spouse) are receiving no additional benefit if their spouse dies before full retirement age
 - iv. Requiring SSA to proactively provide information to widows, orphans, etc. upon the death of a spouse, parent, etc.

 - i. Secretary Ben Carson unveiled a package of rent reforms titled: Making Affordable Housing Work Act.
 - 1. These reforms would cut housing benefits, increase rents, eliminate income deductions for medical or childcare expenses, and allow Public Housing Authorities (PHAs) and property owners to change rent policies and impose work requirements for residents.
