*Note on methodology:

This analysis includes individuals in the following LIS eligibility categories, as they are likely to also meet the MSP eligibility criteria:

Full LIS Category 1 (no premium for benchmark plans, no deductible, copayments of \$3.70 for generic and \$9.20 for brand in 2021):

- Full-benefit dually eligible individuals with income above 100% FPL and assets below \$7,970 for an individual
- Partial-benefit dually eligible individuals (those enrolled only in a Medicare Savings Program, not also receiving Medicaid coverage of medical services)
- Individuals with Medicare with income below 135% FPL and assets below \$7,970 for an individual

Full LIS Category 2 (no premium for benchmark plans, no deductible, copayments of \$1.30 for generic and \$4.00 for brand in 2021):

- Full-benefit dually eligible individuals with income below 100% FPL and assets below \$7,970 for an individual

This analysis excludes individuals in the following LIS categories, since they will not necessarily meet the eligibility criteria in all states. Though, we note that they are likely eligible in some states, especially in states that have used 1902(r)(2) authority to increase or eliminate resource limits, or increase income limits, for the MSPs.

Full LIS Category 3 (no premium for benchmark plans, no deductible, \$0 copayment):

- Full-benefit dually eligible individuals residing in an institution
- Full-benefit dually eligible individuals receiving Medicaid home and community-based services

Partial LIS (subsidy covering 75% of the benchmark premium, limited deductible and co-payments):

- Medicare beneficiaries with income below 150% FPL, with assets between \$7,970 and \$13,290 for an individual
