SUBJECT: 2018 Medicare Part D Low-Income Subsidy (LIS) Income and Resource Standards

The purpose of this memorandum is to provide updated income and resource standards for individuals who apply for the low-income subsidy (LIS) for Medicare Part D. The Centers for Medicare & Medicaid Services (CMS) is required by law to update the income and resource limits each year.

Attached are the tables of the 2018 Poverty Guidelines for the 48 contiguous states and the District of Columbia (Attachment 1), Alaska (Attachment 2), and Hawaii (Attachment 3). We have also attached a description of the methodology that CMS used to update resource limits for 2018 (Attachment 4). (These were previously released to plans on November 16, 2017, but are attached here for convenience.) The new income and resource standards will be applied to all LIS applications filed on or after January 1, 2018.

Resource Limits for the Medicare Part D Low-Income Subsidy: Annual Adjustment for 2018

The Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (MMA) directs CMS to update the resource limits for the low-income subsidy each year. This notice provides: (i) the calculation methodology for updating the low-income subsidy resource limits, (ii) the low-income subsidy resource limits in 2018, and (iii) the cost-sharing for low-income subsidy eligible beneficiaries in 2018.

I. Calculation Methodology

Section 1860D-14(a)(3) of the Social Security Act (the Act) requires CMS to use the annual percentage increase in the Consumer Price Index (CPI), All Urban Consumers (all items, U.S. city average) as of September of the previous year to update the resource limits for the low-income subsidy. CMS used the September 2016 and the September 2017 CPI values from the Bureau of Labor Statistics to calculate the annual percentage increase. The annual percentage increase in the CPI for contract year 2018 is calculated as follows:

$$\frac{\text{September 2017 CPI } 246,819}{\text{September 2016 CPI } 241,428} = 1.0223$$

The 2017 adjustment factor for the low-income subsidy resource limits is 2.23%. Per the statute, the resource limits are increased by 2.23% for 2018 and rounded to nearest multiple of \$10. Therefore, the resource limit that must not be exceeded for beneficiaries to qualify for the full low-income subsidy increases from the 2017 amount of \$7,390 (\$11,090 if married) to \$7,560 (\$11,340 if married) in 2018. The resource limit that must not be exceeded for beneficiaries to qualify for partial low-income subsidies increases from the 2017 amount of \$12,320 (\$24,600 if married) to \$12,600 (\$25,150 if married) in 2018.

As mentioned above, if a beneficiary notified SSA that he or she expects to use some of his or her resources for burial expenses, the applicable 2018 resource limits are \$9,060 (\$14,340 if married) for the full low-income subsidy and \$14,100 (\$28,150 if married) for other low-income subsidies.

* Section 3304 of the Affordable Care Act (ACA) amends section 1860D-14(a)(3)(B) of the Act by adding a special rule for widows and widowers regarding eligibility for low-income assistance. Effective 1/1/2011, redeterminations of eligibility for an LIS-eligible individual whose spouse has died are extended for one year beyond the date when his/her eligibility would have otherwise ended.

** Resource limits displayed include \$1,500 per person for burial expenses.

III. Low-Income Subsidy Eligible Beneficiary Cost-sharing

As required under section 1860D-14 of the Act, the maximum copayments below the out-of-pocket threshold for certain low-income full subsidy eligible enrollees and the deductible and the maximum copayments above the out-of-pocket threshold for partial subsidy eligible enrollees are updated using the annual percentage increase in average expenditures for Part D drugs per eligible beneficiary. In addition, the maximum copayments below the out-of-pocket threshold for full-benefit dual eligible enrollees with incomes that do not exceed 100% of the FPL are updated by the annual percentage increase in the CPI, as required under section 1860D-14(a)(4).
